1: The rows that are labeled UNKNOWN on the Medicaid Expenditures Tables in this report (i.e. Table 3.) indicate the amounts that are associated with gross adjustments. Gross adjustments cannot be associated with recipients or paid claims (except Pharmacy adjustments which are claim specific), therefore, they cannot be mapped to a particular eligibility group or age group. Those adjustments that appear in the UNKNOWN column of the Table are adjustments that cannot be mapped to a Type of Service.

2,3: Due to the reporting process, total expenditures for INPATIENT HOSPITAL SERVICES are understated and total expenditures for STERILIZATIONS are overstated by \$3,178,102. For inpatient hospital claims with deliveries that include a sterilization, the total claims amount is being reported under the STERILIZATIONS type of service. The overstated amount represents the part of the claim that was for the delivery, which should be included in the INPATIENT HOSPITAL SERVICES total.

4: The CAPITATED PAYMENT SERVICES type of service includes beneficiaries enrolled in a managed care plan (HMO, PEP) and those enrolled in Palmetto Senior Care. Palmetto Senior Care is being reported with managed care plans due to its capitated payment method for services provided to enrolled recipients.
